RELEASE OF LIABILITY AND ASSUMPTION OF ALL RISKS INVOLVED IN THE LEASE/USE OF A HORSE IS BY THE RIDER AND/OR PARENT/GUARDIAN.

The lease of this horse is made at the request of the Rider or parent/legal guardian whose name is signed at the bottom of this page. In consideration of the permission of Camp Anokijig/Friends of Camp Anokijig Inc. to use its premises and to use its horse, the undersigned does hereby agree to pay in full the agreed rental price for such horse and to assume the entire risk and responsibility for any damages or injuries suffered or sustained in and around the stable of Camp Anokijig/Friends of Camp Anokijig Inc., on the trails, or any other place where said horse might be used.

The Rider/ parent of rider/ or legal guardian of rider recognizes that a horse is a creature capable of and given to independent action; and, while employees/volunteers of Camp Anokijig/Friends of Camp Anokijig Inc. use their best judgment in furnishing the Rider with a horse, Camp Anokijig/Friends of Camp Anokijig Inc., and its employees/ volunteers/officers cannot be and are not responsible for the action of or the suitability of the horse.

In consideration of Camp Anokijig/Friends of Camp Anokijig Inc. assigning to any minor child the use of a horse, the undersigned does hereby agree as parent or legal guardian of said child to indemnify and hold forever harmless Camp Anokijig/Friends of Camp Anokijig Inc., its servants, agents, volunteers, and employees from any action brought by the minor or on behalf of the minor for injuries or damages arising out of the use of a horse leased to said minor and/or parent/legal guardian of said minor. The undersigned expressly agrees that any damages or injuries to said minor arising out of the use of said horse should be assumed entirely by the undersigned.

“NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481 (1) (e) of the Wisconsin Statutes.” By signing this Release, the undersigned acknowledges that he/she has read this Release completely, and understands that by signing he/she has agreed to surrender any past, present, or future claims that he/she has or may have against Camp Anokijig/Friends of Camp Anokijig Inc., or their employees/agents/volunteers, regardless of fault.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. **Camp Anokijig** has put in place preventative measures to reduce the spread of COVID-19; however, **Camp Anokijig cannot guarantee that you will not become infected with COVID-19.** Further, participation could increase your risk of contracting COVID-19.

READ CAREFULLY BEFORE SIGNING – INITIAL EACH PARAGRAPH

____ INITIALS By signing this agreement, I **acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death.** I understand that the risk of becoming exposed to or infected by COVID-19 at Camp Anokijig may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Camp Anokijig's employees, volunteers, and program participants and their families.

____ INITIALS I **voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation at Camp Anokijig.** On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless Camp Anokijig, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Camp Anokijig, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation at Camp Anokijig.

____ INITIALS I represent that I have adequate insurance to cover any injury or illness I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or illness myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.

____ INITIALS In the event that I file a lawsuit, I agree to do so in the state where Camp Anokijig is located, and I further agree that the substantive law of that state shall apply. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

____ INITIALS **By signing this document, I agree that if I am exposed or infected by COVID-19 during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.**

____ INITIALS I **have had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing.** Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain. **I have read and understood this document and I agree to be bound by its terms.**

____ INITIALS If I have signed a separate general waiver of liability connected to my participation at Camp Anokijig, I agree that the terms of that waiver are wholly incorporated into this document and that the terms of this document are incorporated into the separate general waiver.
